The Company warrants this Micro Mesh to be free of defects in workmanship. Examine your Micro Mesh cover carefully before installing. Handle your Micro Mesh cover carefully during inspection and installation as the Manufacturer is not responsible for tears or punctures caused by improper handling.

Micro Mesh pool covers are warranted free of defects for a period of four years from date of purchase on a prorated basis, based on the Manufacturer's suggested retail price. Replacement under this limited warranty is as follows:

**To File A Claim:** Please contact our Customer Service Department at 1-800-356-3025 to speak with a representative. Have your customer number and sales order number available for verification purposes. Photos of the Micro Mesh Cover damage/defects will be required for review. If the Micro Mesh Cover is deemed to be covered under warranty you may be asked to send a 12-inch by 12-inch section of the damaged/defective area to the address in the top right hand corner of this Warranty sheet. Include a copy of your sales order receipt with the submitted sample. Collect shipments will be refused.

**IMPORTANT NOTE:** Many above ground pools have sharp corners where segments of components join. Pad these sharp edges with any soft material such as burlap, foam rubber, etc., to avoid wear and cutting of the Micro Mesh. Failure to do this voids your Warranty. This Warranty specifically does not cover damage to the Micro Mesh Cover due to wear caused by sharp instruments or abrasion. Micro Mesh Covers must also be removed before first snowfall and ice storms. Excessive abrasion and grommets pulling out are specifically excluded from this Warranty.

THE COMPANY AND ITS DISTRUBUTORS DISCLAIM ALL OTHER WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. REPLACEMENT OF DEFECTIVE PRODUCTS AS PROVIDED UNDER THIS WARRANTY IS YOUR EXCLUSIVE REMEDY.
